FAIR PARTICIPANTS & CAMPERS REQUIREMENTS

- 1. Possession or use of alcohol or illegal drugs by ANYONE involved in the 4-H livestock Program or fair activities is strictly prohibited.
- 2. Fire arms are strictly prohibited. Any weapon or article construed to be a weapon is prohibited.
- 3. All University of Kentucky property is tobacco free; this includes barns, Franks Extension Community Building, and campsites.
- 4. All vehicles must be parked in areas designated by the Boyd County Cooperative Extension Service staff.
- 5. Anyone staying overnight MUST be registered with the Boyd County Cooperative Extension Service staff. Only those registered will be permitted to stay overnight or camp. Registration packets will be available through the Boyd County 4-H office and MUST be complete before unloading any animals.
- 6. Anyone not staying overnight MUST leave the property by 11:00 pm. Security will ask anyone not registered to leave the property.
- 7. Anyone staying overnight MUST present proper ID if requested. All overnight campers must have photo id.
- 8. Profanity or vulgarity in speech, manner or dress is not acceptable at any time during the county fair.
- 9. Fireworks are prohibited.
- 10. Shoes with ties or straps are to be worn at all times. Flip-flops should not be worn. Tennis shoes or sandals with straps are highly recommended for safety. Shirts and pants are to be worn at all times.
- 11. No participant is to be around or on maintenance equipment parked or being used on Boyd County Extension property.
- 12. Grounds are to be kept clean at all times.
- 13. Participants are expected to leave the barns, facilities and grounds clean and orderly.
- 14. ONLY 4-H/FFA registered animals are allowed to be housed on the property during the fair.
- 15. Participants are to respect Boyd County Extension property. Any malicious or intentional damage to property shall be paid for by the participant and/or parent or guardian.
- 16. We care about the safety of your child, incidents of serious misbehavior (i.e. fighting, bullying, causing injury, alcohol/drug incidents, any altercations between adults and/or minors, intentional property damage/vandalism, etc.) will be reported to the Boyd County Cooperative Extension staff or representative and grounds security and an incident report will be completed and submitted to the proper authorities.
- 17. Bullying, hazing or malicious pranks (i.e.: shaving cream, toothpaste in pillow/sleeping bags, defacing property) will not be tolerated and may result in the perpetrator(s) being sent home and not allowed to participate in further fair events.
- 18. The consequences of flagrant violation of the above rules, following consultation of those concerned (i.e. barn superintendents, County Extension Agents, and participant/s), may result in the offender being sent home without further participation in the fair or livestock auction.
- 19. Any person under 18 years of age staying overnight must be accompanied by a parent/guardian.
